Registration Process

2. Include a Letter of Interest addressing (1) why you want to attend, (2) what experience you offer to other participants and (3) your own leadership values and why they are important to you.
3. Send your application and materials to your sponsoring supervisor (unless self-sponsored).
4. Sponsoring supervisor prepares and attaches a Letter of Recommendation and sends all materials to authorizing supervisor, if necessary.
5. Authorizing supervisor signs application confirming candidate's availability, the tuition responsibility and understanding of the cancellation policy.

Cancellation Policy for All Applicants: Once admitted, no agency substitutions are allowed. If you cancel after accepting your admission invitation, your place will be given to the next eligible candidate, as determined by the Admissions Committee, and you will be subject to the following cancellation fees:

- Cancel before August 31, 2019: \$750 penalty
- Cancel September 1 – September 10, 2019: \$2000 penalty
- No refunds after September 11, 2019. Full tuition is required
